

# FOR THE CHILDREN...A Divorce Education Program for Parents

## Parents are forever

Divorce is a very stressful experience for parents and children. Although spouses may decide to end their marriage, their children will always need both their parents to be part of their life. This 2½ hour educational program will focus on what children need during and after the divorce and how parents can help them succeed. It is conducted by qualified professionals from OSU Extension and the Delaware Community.

## Who must attend

By local rule of the Delaware County Court of Common Pleas, Domestic Relations Division, all parents with minor children who are parties to a divorce, dissolution, or legal separation action must attend. Other concerned people (grandparents, attorneys, friends, counselors, etc.) may attend voluntarily, but approval for guests to attend must be obtained at the time of pre-registration.

## Pre-registration

Pre-registration is required. Parents who have not pre-registered will not be admitted. Call OSU Extension office at 740-833-2030 for seminar dates and to pre-register. Please give your court case number when you pre-register. You and your child's other parent will each need to pre-register separately and may attend separate sessions if requested.

A certificate of attendance will be given to participants who complete the entire session. The program will notify the court of your attendance.

NOTE: Please arrive 10 minutes before your scheduled session to sign in, receive materials and pay registration fee (if not paid in advance). Anyone arriving after the starting time of the program will not be admitted.

## Time

The program will be offered the first Wednesday evening of each month (except July) beginning at 6:00 p.m. and ending at 8:30 p.m.

## Location

The program will be held at the Willis Building, 2079 U.S. Highway 23 N., Delaware, Ohio **OR** in the Delaware County Commissioner's Building, 101 North Sandusky Street, Delaware (enter building from Court Street entrance).

**Please refer to your confirmation letter from the OSU Extension Office for the location.**

A \$30.00 fee per participant is payable to OSU Extension at the time of attendance. Check or cash; no credit cards please.
